For non-profits and artisans

This application must be filled out and mailed to the New Canaan Farmers' Market Master, Alexis Gazy, for consideration of your product(s) to be sold at the market.

Please enclose at least 2 different 4"X6" color photos of your products. Make sure that you put your name on the back and include size of products shown. Non-profit applicants will give a brief description of their charity/cause and provide the necessary proof of non-profit status.

Only New Canaan artisans (products produced by New Canaan resident or in New Canaan) and non-profit organizations of New Canaan are eligible to apply. Non New Canaan food banks and emergency aid non-profits will be considered. New Canaan merchants working in conjunction with farmers or eligible non-profits will be considered.

The Market Master (Alexis Gazy) is the sole decision-maker as to entry to the Market.

All applications will be reviewed on a first-come, first-served basis. Space is limited to one artisan and one non-profit per week. Each artisan/non-profit is limited to one market per month and three markets per year unless no other qualified applicant is seeking a spot. At that time a random choice will be made from those who have reached their limit of involvement for that month/year and wish to participate further. Previous participation in the market does not guarantee returning acceptance.

- sign a waiver stating that you will not hold the New Canaan Farmers' Market nor the Town of New Canaan liable for any damage or theft of your work or any personal bodily harm or injury that occur to you while you are participating in the market;
- if an artisan-crafter, be the primary representative of your product at the market;
- provide your own tables and one (1) 10x10 tent;
- provide signage and pricing of your products;
- provide a certificate of insurance listing the Town of New Canaan and the New Canaan Farmers' Market additionally insured; and
- abide by all other market rules that pertain to your participation in the market.
